### **Unit Overview**

The theme for this unit is the General Ledger. Students are introduced to the accounting concepts and practices related to posting from a journal to a general ledger. Emphasis is placed on preparation of a chart of accounts for a service business organized as a proprietorship. Following the input of data into the general ledger, correcting entries and analyses are performed. This theme is a prelude to future learning with respect to cash control systems and preparation of financial statements, utilizing information from the general ledger.

# **Enduring Understanding**

- The accounting process of posting to a general ledger is one by which we summarize changes to individual accounts throughout an a cycle.
- Students, throughout their lives should be able to assess the state of a business by analyzing balance sheet accounts within a general ledger..

- Students, throughout their lives will be cognizant of criteria related to preparation of a chart of accounts and apply the concepts to personal money management.
- Understand the elements of a "balance-ruled" account form.


