## **Unit Overview**

---

In this unit students will make the connection between the U.S. Constitution and the criminal justice system. Students will begin to interpret the Constitution and discover the rights of due process of law. Students will study the 4th & 5th Amendments and other basic human rights protections afforded by the Bill of Rights. Students will study landmark U.S. Supreme Court decisions defining our rights and the limits on government power in enforcing the law.

## **Enduring Understanding**

---

Patrick Henry said "The Constitution is not an instrument for the government to restrain the people, it is an instrument for the people to restrain the government." With this in mind students will discover the relationship between the U.S. Constitution and the Criminal Justice System (CJS). Students will comprehend issues of due process and police use of force and how the U.S. Constitution protects citizens rights. Students will realize the power of the Constitution as a shield against human rights violations by individuals, businesses or the government. Students will observe the evolution of the CJS as individual, social, and political norms change and observe how courtroom procedure is designed to guarantee equal and fair application of the law.

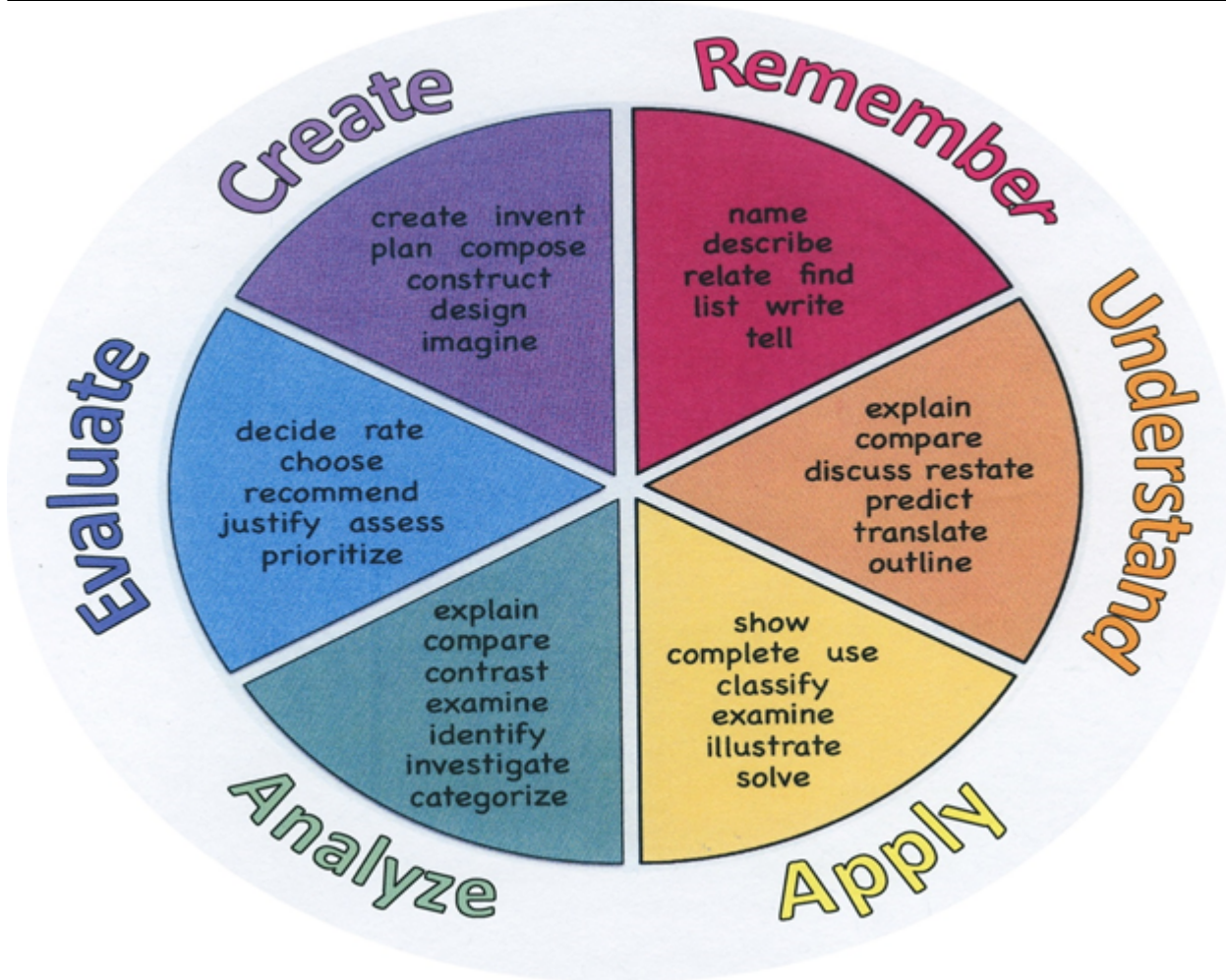
