## **Unit Overview**

---

In this Unit students will analyze various aspects of the American Legal System. The unit begins with a review of critical thinking and legal reasoning skills utilized in the legal services industry. Students will utilize mock trial skills learned and developed in Law I & Law II. Students will prep a case for trial. Students will work in co-operative groups to gather, organize and present information during a mock trial. Students will develop questioning techniques and public speaking strategies to advocate for opposing sides of a legal dispute.

## **Enduring Understanding**

---

Students will realize that critical thinking and legal reasoning problem solving skills are transferable to other learning disciplines. Students will comprehend the importance of problem solving skills and making the most persuasive argument within a given factual scenario. Writing, speaking, and listening skills are constantly being developed through practice and observation.

## **Essential Questions**

---

- What are the elements of effective writing, speaking, and listening skills?
- How can we discern facts from fabrication?
- What are the elements of a persuasive argument?
- How can information technology tools aid in the gathering, organizing, and presentation of a persuasive argument?
