3-5 Music Unit 1 (Rhythmic Elements)

Unit Overview

In this unit, students will explore the elements of **Rhythm**, **Meter**, **Beat and Tempo** as they are found in a variety of cultures and historical periods. Teachers will develop students' knowledge of these musical elements by leading them through the Artistic Processes: Creating, Performing, Responding, and Connecting. Within these processes, students learn to think like musicians utilizing the practices relevant to the musical task-at-hand. Using varied media, instructional approaches, and assessment strategies, teachers will facilitate student learning toward communicating with basic literacy. Students should be able to communicate using the vocabulary, materials, tools, techniques, and intellectual methods of the discipline in a developmentally appropriate manner. Demonstrated growth in each process will be measured based on specific performance expectations connected to the Anchor Standards. Students in 4th and 5th grades have the opportunity to further enhance their experience, and deep their understanding in, these elements through participation in instrumental and/or vocal ensemble music.

Exemplar Learning Activities

CREATING

- Create music combining various rhythms and meters.
- Notate simple rhythms within a specified meter.
- Students work in small groups to share and refine musical ideas.
- Students notate compositions based on chosen purpose and context, students improvise musical ideas, motives, rhythms, sounds and silences.
- Students will perform pre-written music using a variety of rhythms and various meters.
- Composing musical ideas.

PERFORMING

- Students perform on musical instruments to create recordings.
- Students perform peer compositions from notation.
- Perform musical works on musical instrument
- Perform compositions on stage in a formal concert for students, family, and community
- Students perform choreographed dances in asymmetric meters.
- Students engage in play along activities, adding typical rhythmic ostinato to world music examples.
- Perform rhythmic accompaniments within specified guidelines and major and minor tone sets.
- Perform music using contrasting tempo.

RESPONDING

- Students discuss and/or write about the impact of the music and its meaning or purpose in its authentic context.
- Recognize tempo changes in listening examples and be able to describe them using age/developmentally appropriate terminology.
- Students will perform age/developmentally appropriate repertoire and will reflect on their performance through guided questions from the teacher.
- Student reflects on his or her performance and adjusts the performance with reasons for the adjustments and presents changes in future performances.
- Students will reflect on their performance based on questioning from the teacher and through discussion about the technical aspects of their performance.
- Students can discuss, using musical vocabulary, the characteristics of the music they hear and/or perform.

CONNECTING

- Write reviews of performances
- Students write reflections following the performance, evaluating their own and peer compositions.
- Teachers will choose age/developmentally appropriate repertoire and discuss the characteristics of the

music in age/developmentally appropriate language and will guide the students to select and state preferences for the music used in the classroom.

- Students will be able to discuss, using age/developmentally appropriate musical language, what sort of music they like personally and why.
- Students create music to evoke an emotion, imitate styles, or make a connection to something in their life.
