## Brief Summary of Unit

---

The student will learn how to use basic recording software to record their music. Microphone selection and placement will be discussed and modeled. Basic techniques of recording other instruments common to rock, pop, jazz, and classical music will also be demonstrated.

- How to add other instruments and mix their projects.
- That there are many methods used in recording music.
- What different types of microphones there are and what they are used for.
- Adding other instruments to their recordings.
- Recording their music.
- Selecting and placing appropriate microphones.

### **Transfer**

- The students will be able to record, copyright, and market their own music.

### **Evidence/Performance Tasks**

- Each aspect of this project will have a detailed rubric outlining student tasks.
- The student will be required to record one of their own songs.

### **Learning Plan**

- Provide a rubric for students to follow to understand the steps in the recording project.
- Using a song from the previous composition unit, students will prepare their composition for recording.
- Provide demonstration and practice of using recording software.
- Record an entire song as a final project to this unit.

- Computer with recording software (protools)
- Recording microphones (Shure SM57 dynamic) (variety of condensers)
- Smartboard with internet access
