

Unit 3: Unification and Theme

Brief Summary of Unit

Students will master an understanding of the contribution of thematic development to the coverage of the yearbook. Students will be involved in activities to create and foster theme. In the end, they will develop a theme and artwork for the following year's book. Additionally, students will work on team-building activities and work together to create ideas and products.

Interdisciplinary Connections and Career Readiness:

This unit is designed to be part of a developmental progression across grade levels and make interdisciplinary connections across content areas including physical and social sciences, technology, career readiness, cultural awareness, and global citizenship. During this course, students are provided with opportunities to develop skills that pertain to a variety of careers. When completing this course, students can make informed choices and pursue electives that further their study and contribute toward the formation of career interest.

Essential Questions

- How can a theme be portrayed in both a visual and verbal context?
- How can communication foster the success or failure of a team?
- How can students work together toward common goals?
- How can theme unify a team as well as a book?
- What artistic/design elements can link a theme to a spread?
- What does it mean to be part of a team?
- What makes a good theme?

Essential Understandings

- A thematic relationship should exist between all the pages in design and content throughout the book.
- A theme is a creative idea that has a visual and verbal appeal to the emotions.
- Being part of a team requires knowing your strengths and weaknesses and playing to them.
- Continuity in the book relies on the strength of the theme as well as the staff.
- Themes are general, big ideas that can be universal while at the same time making a statement about our school.
- Working in a group requires positive contributions and good communication from everyone.

Students Will Know

- Guidelines for theme development
- How to determine, support, and justify a theme
- How to identify specific pages and sections through graphics, typography, photos, and copy.
- That reader appeal is important in both visual and verbal components of a theme
- Unifying elements are aspects of design including graphics, typography, photos, and copy types that adhere to a certain visual or verbal theme that is consistent throughout the book.

Students Will Be Skilled At

- Designing thematic content

- Identifying theme through graphics, typography, photography, and copywriting
- Justifying the significance of a theme
- Working as a team

Evidence/Performance Tasks

Developmental progression across years in both reading and writing is evidenced by multiple benchmark assessment screeners, administered two times per year. Follow up diagnostic assessments are used to target skill remediation. Student proficiency allows for additional or alternative assessment based on demonstration or absence of skill.

Students demonstrate differentiated proficiency through both formative and summative assessments in the classroom. Based on individual student readiness and performance, assessments can be implemented as formative and/or summative.

Learning Plan

Teaching Point: A yearbook staff is a team that works together to accomplish goals. Possible Activities: 1. Team building activities from Jostens Units 2. Brainstorm and create goals for the yearbook and ways the team can achieve them 3. Think about and discuss team members' strengths and ways in which they feel they can best contribute 4. Set up a communication system between students in order to ensure success.**Have students choose tasks to work on for the final deadlines of the current yearbook**

Teaching Point: Themes are universal, but also speak to something specific about our school. Possible Activities: 1. Introduce thematic language and terms 2. Identify and evaluate thematic elements in past yearbooks 3. Brainstorm thematic ideas for next year's yearbook

Teaching Point: Themes have both visual and verbal appeal. Possible Activities: 1. Go through past yearbooks and identify how the creators used visual and verbal elements in covers, dividers, intros and conclusions. 2. Evaluate and provide constructive criticism on past themes. 3. Create thematic ideas for covers, dividers, intros and conclusions and justify how this can be carried through the yearbook and why it applies as a universal idea and something specific to our school. 4. Present thematic ideas, justify, and vote on ideas

Strategies for Accommodation and Modification

Possible accommodations include:

- Access speech-to-text function on computer
- Use visual presentations of all materials to include organizers, charts
- Allow students to set individual goals for writing/reading
- Offer graphic organizaers, note-taking models, strategies for summarizing, and questioning techniques
- Offer oral assessments
- Supply study guide questions and access to class notes
- Work in partnerships
- Give responses in a form (verbal or written) that is easier for the student
- Take additional time to complete a task or project
- Scaffold by chunking material and texts
- Individualize reading choices based on ability and level
- Take frequent breaks
- Use an alarm to help with time management
- Small group and one on one assessment
- Mark text with a highlighter or other manipulative such as a post-it
- Receive help coordinating assignments
- Answering fewer questions or completing shorter tasks
- Modify the length and quantity of assignments to fit individual
- Differentiate roles in discussion groups
- Use digital technology, eBooks,, audio version of printed text
