

# Unit 1: Ethics

## Brief Summary of Unit

---

Students will review all facets of publication law that affect the publishing of the yearbook.

### Interdisciplinary Connections and Career Readiness:

This unit is designed to be part of a developmental progression across grade levels and make interdisciplinary connections across content areas including physical and social sciences, technology, career readiness, cultural awareness, and global citizenship. During this course, students are provided with opportunities to develop skills that pertain to a variety of careers. When completing this course, students can make informed choices and pursue electives that further their study and contribute toward the formation of career interest.

## Essential Questions

---

- As a photojournalist, what places should be off-limits?
- How can you avoid problems in judgment when choosing photographs or writing copy?
- How does the Hazelwood case affect prior review and prior restraint?
- How is the First Amendment involved in constructing a yearbook?
- How should you deal with your personal feelings when selecting pictures and writing copy?

- Is good taste a matter a personal opinion or a societal opinion in publications?
- What is your liability in terms of libel, invasion of privacy, and copyright infringement?
- Why are student journalists held to such a high standard?

## **Essential Understandings**

---

- All photos and copy must portray people in a “good light”.
- Being a journalist requires moral and ethical responsibility.
- Good taste and sound judgment must be used in all facets of publications.
- Good taste is defined by a societal standard.
- Personal feelings should be left out of yearbook coverage entirely.
- The yearbook involves a contractual commitment with Jostens.

## **Evidence/Performance Tasks**

---

Developmental progression across years in both reading and writing is evidenced by multiple benchmark assessment screeners, administered two times per year. Follow up diagnostic assessments are used to target skill remediation. Student proficiency allows for additional or alternative assessment based on demonstration or absence of skill.

Students demonstrate differentiated proficiency through both formative and summative assessments in the classroom. Based on individual student readiness and performance, assessments can be implemented as formative and/or summative.

## **Learning Plan**

---

Teaching Point: Being a journalist requires moral and ethical responsibility. Possible Activities: 1. Review and discuss defamation, libel, and invasion of privacy. 2. Review the 4 elements of libel and evaluate statements to identify them 3. Discuss ways to avoid libel/defamation/invasion of privacy in the yearbook. 4. Review copyright law and discuss examples. 5. Discuss ways to avoid copyright infringement in the yearbook.

Teaching Point: Personal feelings should be left out of yearbook coverage entirely. Possible Activities: 1. View and discuss videos such as “How journalists minimize bias” <https://www.facinghistory.org/resource-library/video/how-journalists-minimize-bias> 2. Discuss ways in which news reporting and copywriting for the yearbook are related. 3. View photos (curated by the teacher in advance) and have students practice writing unbiased copy. 4. Present students with situations of bias and have them discuss the appropriate action to take (ex. “Johnny broke up with Suzie Q on the yearbook staff and doesn’t want to include any photos of him in the yearbook. What would you do?”) 5. Have students evaluate past spreads for bias.

Teaching Point: Good taste and sound judgment must be used in all facets of publications. Possible Activities: 1. Discuss the importance of portraying everyone in “a good light”. 2. View photos and have students choose the best photos to portray the most positive light (ex. A photo of the goalie on the Boys Soccer team blocking a goal vs. one of him allowing a goal; A caption about school lunches using positive or neutral words vs. one using negative connotations, etc). 3. Discuss the societal definition of good taste and identify things that are in good taste and in bad taste. 4. Review and discuss issues of privacy.

## **Strategies for Accommodation and Modification**

---

[Content specific accommodations and modifications as well as Career Ready Practices are listed here](#) for all students, including: Special Education, English Language Learners, At Risk of School Failure, Gifted and Talented, Students with 504.

Possible accommodations include:

- Access speech-to-text function on computer
- Use visual presentations of all materials to include organizers, charts
- Allow students to set individual goals for writing/reading
- Offer graphic organizers, note-taking models, strategies for summarizing, and questioning techniques
- Offer oral assessments
- Supply study guide questions and access to class notes
- Work in partnerships
- Give responses in a form (verbal or written) that is easier for the student
- Take additional time to complete a task or project
- Scaffold by chunking material and texts
- Individualize reading choices based on ability and level
- Take frequent breaks
- Use an alarm to help with time management
- Small group and one on one assessment
- Mark text with a highlighter or other manipulative such as a post-it
- Receive help coordinating assignments
- Answering fewer questions or completing shorter tasks
- Modify the length and quantity of assignments to fit individual
- Differentiate roles in discussion groups
- Use digital technology, eBooks,, audio version of printed text
- Create alternate assignments or homework
- Provide distinct steps in a process; eliminate unnecessary steps, as needed
- Use art, music, and film to convey alternate interpretation of literature and assessment
- Manage executive function by scaffolding process and amending deadlines
