Brief Summary of Unit

This unit teaches students effective information gathering and writing techniques for copy in publishing.

Interdisciplinary Connections and Career Readiness:

This unit is designed to be part of a developmental progression across grade levels and make interdisciplinary connections across content areas including physical and social sciences, technology, career readiness, cultural awareness, and global citizenship. During this course, students are provided with opportunities to develop skills that pertain to a variety of careers. When completing this course, students can make informed choices and pursue electives that further their study and contribute toward the formation of career interest.

Essential Questions

- How do various writing techniques on a DPS add to the overall impression of a layout?
- In lieu of a traditional story, what are some alternative layout strategies?
- What are the guidelines for interviewing people and using quotes in the yearbook?
- What makes a story or article engaging?

Essential Understandings

- All copy must be revised, edited, and proofread prior to submission
- · Each section has its own design for a story
- · Effective writing requires multiple drafts.
- Individuals must be identified in all captions and names must be double checked for accuracy.
- Staffers must follow the guidelines of good ethics when gathering information for a story.
- Templates are a guideline and don't need to be strictly adhered to as long as the layouts look unified.
- Thoughtful questions must be planned out in advance of an interview and the quoted party must sign all quotes to be used in the yearbook.

Students Will Know

- The parts of an effective story: theme, research, angle, lead, transition, word choice, description, interpretation, mechanics, accuracy, unity
- The proper format for caption writing, including who, what, when, where, why, how
- The three basic types of copy and how to define the roles of the story, headlines, and captions.

Students Will Be Skilled At

- How to use and write alternatives to traditional stories.
- Interviewing students and staff to get quotes and information for stories and captions.
- · Revising, editing, and proofreading.
- Writing captions, leads, and creative headlines

Evidence/Performance Tasks

Developmental progression across years in both reading and writing is evidenced by multiple benchmark assessment screeners, administered two times per year. Follow up diagnostic assessments are used to target skill remediation. Student proficiency allows for additional or alternative assessment based on demonstration or absence of skill.

Students demonstrate differentiated proficiency through both formative and summative assessments in the classroom. Based on individual student readiness and performance, assessments can be implemented as formative and/or summative.

Learning Plan

Teaching Point: There are many aspects of an effective, engaging story. Possible Activities: 1. Look at magazine articles and discuss what makes the stories engaging or entertaining. 2. Look at previous yearbooks and books from other schools and discuss the types of stories involved. 3. Present the types of copy and parts of an effective story. 4. Identify from magazines and previous yearbooks ways of including information without writing a traditional story. 5. Brainstorm ways you can convey relevant information without a traditional story.

Teaching Point: Effective writing requires multiple drafts. Possible ActivityEach student writes a short quick story, either from imagination or from some sort of visual prompt and students pass the stories around while editing, revising, and proofreading to make them better. Compare and contrast first drafts and final drafts.

Teaching Point: Templates are a guideline and don't need to be strictly adhered to as long as the layouts look unified. Possible Activities: 1. Students look through old yearbooks and notice what slight differences exist from page to page and what largely stays the same within each section. 2. Show students the Modules on the design program and how they can put slightly different elements in each module without changing the entire look of the page. 3. Students discuss what types of things can be changed within templates without entirely changing and what things need to stay the same.

Teaching Point: Good interviews are planned out in advance of the conversation. Possible Activities:

- 1. Students come up with interesting questions or topics for interviews for various pages in groups or individually.
- 2. Mock interviews in class with each other.
- 3. Students actually go out and speak with students and staff on previously decided topics.

Throughout the unit, students will: Gather information ethically for a story; Identify all students in captions for each photo; Double check names for accuracy; Conduct interviews and have interviewees sign off on all quotes to be used in the yearbook; Revise, edit, and proofread each other's copy; Meet regularly to discuss effectiveness of copy and determine sectional design for copywriting; Editors will meet with staff to disperse writing and research assignments; Research designated topics using the computer and CHS community.

Strategies for Accommodation and Modification

- Answering fewer questions or completing shorter tasks
- Modify the length and quantity of assignments to fit individual
- Differentiate roles in discussion groups
- Use digital technology, eBooks,, audio version of printed text
- Create alternate assignments or homework
- Provide distinct steps in a process; elminate unnecessary steps, as needed
- Use art, music, and film to convey alternate interpretation of literature and assessment
- Manage executive function by scaffolding process and amending deadlines
