# 3: Subject Matter Unit

Content Area: Art

Course(s): Studio Art I

#### **Unit Overview**

In this unit, the students will be learn about how the usage of and selection of subject matter can affect their work. The students will learn about subject matter through vetting subjects that have aesthetic value, social and cultural implications, and personal relevance.
