#### **Unit Overview**

Feature articles are informative, explantory pieces that profile people, examine a topic, analyze events, explore trends, evoke an emotional response, and cover in-depth stories. They appear in magazine, newspapers, newsletters, web sites, reference works and collections of writings.



#### **Accomodations/Modifications**

Build background knowledge by showing pictures of braces and discussing why and when someone might need braces. Review unfamiliar vocabulary words and cognates to help students develop vocabulary independently.
