- The primary focus of this unit is to analyze the ways in which language expresses and creates meaning. This will include a study of rhetoric in literary and informational texts, as well as various media sources.
- The secondary focus of this unit will be to examine the ways in which historical, political, social and cultural context informs literary works. We will explore ways that authors draw from and expand on literary traditions.
