- Critical textual annotation will be taught in addition to syntax variety, figurative language, and narrative structure.
- Developing well-organized textual evidence to support written and oral analysis of a given text.
- Explain the essential components of a tragedy and a tragic hero.
- Explain what makes a classic piece of literature relatable and enduring.
- Identify how writers use dialogue for characterization.
- Identify the use of dramatic irony to create tension and suspense in a play.
- Respond to assigned secondary, informational readings and/or short videos.
- Respond to specific passages in the primary text to analyze literary elements and in response to narrative structure, the development of characters and themes, and figurative language.
- Use context clues to guess the meaning of new words.

Instructional Tasks/Activities

- Akala TEDTalk
- Compare the same story as told in various genres (See “Romeo and Juliet” by Dire Straits, “Romeo and Juliet” by Indigo Girls, “Romeo and Juliet” by The Killers, “Love Story” by Taylor Swift)
- Discuss the interaction between teens and adults, and examine the problems that could have been avoided.
- Essay Prompt: "Which character other than Romeo or Juliet is most responsible for their death?"
- Examine the elements of a tragic hero’s rise and fall and discuss the extent to which he could control the outcome of the story.
- Isolate, define, and use new vocabulary.
- Learn the building blocks of drama, including such elements as monologue, soliloquy, and stage directions.
- Role Play: Assign each student a role and act out scenes from each play, figuring out what each actor would be doing according to the text of the play.

- Scene 2.2 Graphic Organizer
- Sonnet 18
- Sonnet Love Poem Activity
- Study the language, style, and tone of famous monologues and soliloquies from the play. Record detailed notes explaining the author’s choices.
- Watch different film versions of the play Romeo and Juliet. Discuss how each director interprets the language, characters, and meaning through his or her artistic choices.
