Unit Overview

Students will read a novel and variety of short stories to focus on the following skills: narrative elements, plot development, characterization, setting, theme development, narration; vocabulary development through context clues and use of references; drawing conclusions, making inferences, forming opinions, comparing and contrasting; understanding dystopian and utopian societies; understanding literary devices, i.e. figurative language, irony, foreshadowing, flashback, allusion, analogy, etc.; critical thinking; writing responses to short-answer and open-ended questions in a manner that includes text references as support and extended thinking; fluent and expressive oral reading.

Enduring Understandings

Personal experience affects the reader's point of view and his/her ability to connect with the story.

Proficient readers use comprehension strategies to enhance their understanding of a story.
Literature is a reflection of real life.
